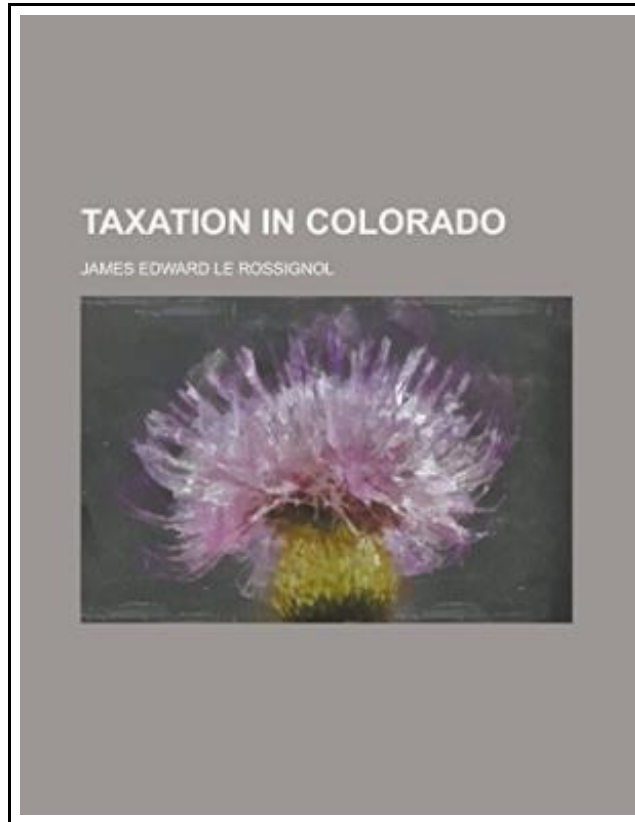

A corporation is worth, then, the capitalized value of present or prospective earnings, and this capitalized value is the amount which the property will bring at a fair voluntary sale. When the net income is fixed and certain, as in the case of gilt-edged bonds, the rate of capitalization is low, say four or five per cent. When the net revenue...
